#### **TABE Minimum Standards**

In order to be a program completer, students must meet the minimum math and reading achievement level exit standards on the TABE, unless otherwise exempt, as established by the Florida Department of Education. The minimum exit standards for each program, as well as exemption details, may be obtained from the Office for Adult Technical Education.

#### Uniforms

This program requires a uniform be worn daily. The program level will determine the color of the uniform, which consists of a pullover top with elastic or drawstring pants, black or white professional shoes, socks or hose and a uniform jacket for cool days. Uniforms may be purchased locally and more specific information will be provided upon acceptance into the program. A minimum of two complete uniforms and one jacket is required to maintain proper hygiene and cleanliness.

#### Licensure

In order to sit for the Florida Board of Cosmetology Exam, you must be at least 16 years of age, have completed 1,200 school hours in a cosmetology program, and must submit the initial HIV/AIDS course completion certificate.
